**What is the Performance Based Contract?**

On January 1, 1993, Senate Bill 1383 amended the Lanterman Act requiring a five-year performance contract between each regional center and the Department of Developmental Services (DDS).

In 2002 DDS created a new performance contract that establishes a comprehensive performance-based accountability system for regional centers. The contract includes goals such as 1) less consumers living in developmental centers, 2) more children and adults living with families or in home settings, and/or 3) less children and adults living in large facilities.

This contract also includes a section for local outcomes, or those developed with input from consumers, families and others. The public meeting is your opportunity to suggest local outcomes that you would like to see added to the 2017 performance contract.

**How can you participate?**

1. Think about local outcomes – are there any measurable areas you would like to see included in VMRC’s 2017 performance contract?
2. Attend a public meeting and share your ideas, or write them on this form and mail it to us by September 30, 2016.

Here are a few examples of measurable local outcomes:

- Number and percent of adults in supported employment
- Number and percent of adults in competitive employment.
