## <u>Description of Project:</u>

Under the direction and supervision of the Clinical Director the Dental Coordinator utilizes clinical skills, expertise and knowledge to provide consultation, education and training to Case Management staff, clients, families and community partners in order to promote oral health.

## Scope of Service:

- 1. Work with contracted dental provider to determine the feasibility of providing virtual dental services to consumers. Cooperate in a pilot project as needed.
- 2. Explore other avenues to bring more dental services to consumers: partnership with St. Raphael clinic at St. Mary's dining hall, Stockton; CDA cares event; Donated Dental services, etc.
- 3. Attend and serve as VMRC representative on the Oral Health Planning committees in all 5 counties.
- 4. Serve on statewide groups advocating for increase in availability of sedated dental care.
- 5. Recruiting and maintaining a relationship with community dentists and dental hygienists who are willing to provide services to people with special needs.
- 6. Act as a resource for problem solving oral health/dental issues with dental and hospital providers.
- 7. Review of dental bills to ensure that all dental work potentially eligible for funding through Denti-Cal was billed properly and appropriate documentation was supplied.
- 8. Review and approval of dental treatment plans and POS requests related to dental needs.
- 9. Training family, residential care providers, and regional center service coordinators about the importance of oral health care and the prevention of dental disease for people with special needs.
- 10. Collaborates with Dental Coordinators of other regional centers on state wide/ARCA issues related to dental care for RC clients.
- 11. Engage the professional dental associations in our region and act as a liaison.
- 12. Integrate behavior consultants to address oral health and dental procedure fears in our consumer population.
- 13. Other duties as assigned.

#### Working Conditions and Physical Requirements:

Applicant(s) must have reliable transportation and be able to travel locally in all areas of San Joaquin, Stanislaus, Amador, Calaveras and Tuolumne counties and out of town as needed. Applicant(s) must have the ability to read, write and comprehend large amounts of written materials. Excellent oral and written skills are essential.

#### Qualifications:

1. Knowledge of oral health and dental issues, including interventions, ethical and legal factors associated with the field. Has the ability to collaborate with a wide range of internal and external customers.

- 2. Registered Dental Hygienist (RDH) currently licensed in the state of California; Registered Dental Hygienist Alternative Practice (RDHAP) preferred.
- 3. At least two years' experience working with individuals with developmental disabilities in a clinical or public health setting.

A Review Committee will evaluate each Letter of Intent, Resume and any other materials or submissions that demonstrates qualification for this consulting position.
