- i. Rate Study- from DDS, all feedback is helpful, they will continue to analyze the information.
- ii. DS Task force will be updating as it goes forward with new members. All members must reapply if want to stay on task force, if interested in joining go to DS website to apply. Even if not on DS Task Force, there are workgroups that you can join, also available on the website. This will be where you will hear about all updates that will be coming.
- iii. Lanterman Act Update Letter was sent out last week, the full letter and presentation summarizing the changes can be viewed on the VMRC website on the Legislative Committee page or on the announcements page.
- iv. Tony asked if anyone has further information on a statement that has been circling around regarding "VMRC has adopted best practices for all vendor categories that they are now interpreting them as a minimum requirement, this is becoming a problem when hiring an administrator for level 3 home. It requires us to submit, in addition to the DDS administrator Certificate, a resume and 3 written references and send the applicant to VMRC for an interview." Brian made the statement that VMRC does not have best practices that have been adopted in all vendor categories. Title 17 requires all administrators to attend the regional center orientation classes, which VMRC only offers twice a year, so they came up with an alternative option of interviewing the candidate about their knowledge about the program design and the basic competencies of an administrator. If anyone has feedback about the situation, please let Brian know.
