PARENTAL VERIFICATION FOR RECEIPT OF BEHAVIORAL SERVICES

Instructions to the Vendor: Section 4686.31 of the Welfare and Institutions code requires any vendor who provides Behavioral Services as specified in Title 17 of the California code of Regulations* to submit a completed verification form to the regional center for services provided to consumers under the age of 18 years who reside in the family home. The vendor must submit the completed verification s to the regional center with the invoices for the services provided. If the parents or legally appointed guardians of a minor consumer do not submit a verification of services to the vendor, the vendor shall contact the regional center. Failure of the parents or legally appointed guardians of a minor consumer to submit a verification of services to the vendor shall not be a basis for terminating or changing behavioral services to the minor consumer.
